7. **CIC and Stated Clerk Reports**

a. **Classis Interim Committee Report (CIC)**

CIC Chair: Doug Nieuwstraten

i. **CIC decided** - upon Stated Clerk's recommendation, *that Classis will handle appointments in the CIC report, not in the Consent Agenda for Classis. It's more personable, can be appropriately discussed, and doesn't give the sense of "just getting it done". This includes all functionaries of Classis, church visitors, counsellors, members of the CIC, etc.*

ii. **Reminder: Annual Signing the Covenant for Office Bearers at Classis.**

From the General Secretary: *"Synod instructed all classes to require all of their delegates to affirm the Covenant for Officebearers at each classis meeting. While Synod 2024 had required that all classes re-sign the Covenant for Officebearers annually, Synod 2025 adjusted this requirement and left the form of affirmation to the discretion of the classis. First-time delegates to classis are to sign. Other delegates may stand, raise their hands, or affirm in another way that is determined by classis. Synod 2025 also stated that the practice of affirmation at the gathering of the classical assembly is to be a celebration of that which unites us and can be observed as an act of worship."* From the FAQ from the General Secretary (<https://www.crcna.org/Synod2025FAQ>)

(1) That describes our present practice and doesn't indicate a needed change.

(2) **Reminder: Classis Hamilton decided to maintain its practice of first time delegates signing the Covenant for Officebearers and, in a manner indicated by the Chair of Classis, the delegates affirm the Covenant at each meeting.**

iii. **Reminder:** As previously decided, **Oral reports at Classis require a written copy** to the Stated Clerk in order to be detailed in the Minutes of Classis.

iv. **Reminder:** Pulpit Supply Schedule: Classis approved **pausing the Pulpit Supply Schedule** from September 2025 and resuming September 2026.

v. **Recommendation:**

(1) ***that Dr. Syd Hielema's role as Regional Pastor in Classis Hamilton be enlarged from co-regional pastor to sole regional pastor.*** (Dr. Hielema's Commissioned Pastor credentials (emeritus) reside at Grace Community CRC).

(2) **Correspondence** from Dave Den Haan, *that Thrive would be happy to note with gratitude Syd's devotion to the work and classis' openness to having him serve in this way. I hope, in time, that someone will observe the excellent work that Syd does and be inspired to come alongside him in it.*

i. The bulk of my work since before October 2025, has been helping Councils and Ministers navigate, research, and provide wording, and church order references in the process of resigning, disaffiliation and all that that implies. It has involved hundreds of emails, more phone calls than usual, meetings, and much pondering and prayer.

Every situation is different, and much of this has been new—to me, to Classis, and in some cases, to the denomination itself. Truly, it has been a season of learning for everyone.

The aim throughout has been to act with care, to honour Christ, and to respond in love at every step. While the agenda may look orderly and under control, behind the links to documents, emails, and letters of resigning, disaffiliation and requests, no one has it all together, no one is happy about these events. Resignations and disaffiliations are difficult, and most are praying and hoping that relationships with friends, family and church connections remain as strong as possible.

- c. **Note: Regarding CO Art 14-b Supplement**
 - i. when Classis releases a Minister of the Word, Classis is to assign one of the four following categories reflecting the resigned minister's status:
 - (1) The resigned minister is *honourably released*.
 - (2) The resigned minister is *released*.
 - (3) The resigned minister is *dismissed*.
 - (4) The resigned minister is in the *status of one deposed*.

- d. **Rev. Steve Dykstra** (CO Art 14-b)

- e. **Rev. Everett Vander Horst** (CO Art 14-b)
 - i. Calling church **Meadowlands Fellowship** has received **Rev. Vander Horst's resignation** (January 19, 2026), and,

 - (1) Suggested motion: ***That Classis declare Rev. Everett Vander Horst honourably released from office***
 - (2) Discussion on the motion
 - (3) Synodical Deputies leave to prepare their advice
 - (4) Voting by Classis, Synodical Deputies return, Classis Decision is announced
 - (5) Synodical Deputies announce their advice
- f. **Following Church Order Art 24-d and supplement**
 - i. *A commissioned pastor position may be eliminated and a commissioned pastor may be released only with the concurrence of the classis that approved the position, with attention to the rules and processes approved by synod.*

Supplement, Church Order Art 24-d

Synod has offered, on various occasions, guidelines regarding the conclusion of an approved commissioned pastor position, the resignation of a commissioned pastor, and the release of a commissioned pastor. Synod also instructs classes to make an appropriate declaration reflecting the status of any commissioned pastor who concludes service. These guidelines and options regarding status are the same as those for minister of the Word and can be found in Supplement, Article 14-b, c, 2 or in the Commissioned Pastor Handbook.

- g. **Commissioned Pastor Marja Fledderus** (CO Art 24-d and supplement)
 - i. Calling church **Meadowlands Fellowship** has received **Pastor Marja's resignation** (January 13, 2026), and,
 - ii. **Requests that she be honourably released from office**
 - (1) Suggested motion: ***That Classis declare Commissioned Pastor Marja Fledderus honourably released from office***
 - (2) Discussion on the motion, and voting by Classis
 - (3) Synodical Deputy advice not required since this is a decision limited to Classis.

13. Disaffiliation from the CRCNA

- a. **Meadowlands Fellowship CRC (MFCRC)** ([Church Order Art. 38 f and supplement](#))
 - i. At the [October 28, 2025 meeting of Classis](#) (See minute 24 a-g), MFCRC submitted its intention to disaffiliate from the CRCNA.
 - ii. MFCRC, CIC and Classis followed the steps outlined in supplement Art 38-f
 - iii. MFCRC held two congregation meetings each with voting by the membership with the result that the Council now gives its resolution that it is disaffiliating from the CRCNA
 - iv. [Resolution by MFCRC](#)
 - v. Suggested Motion: ***that Classis acquiesce in the decision of the congregation to disaffiliate from the denomination***
 - vi. Discussion on the motion and voting
 - vii. CO Art supplement 38-f, f states "... classis shall provide for the pastoral care of those members who wish to remain within the denomination."
- b. **New Hope (Emerging congregation)** under First Hamilton CRC's supervision (FHCRC)
 - i. FHCRC informs Classis that [New Hope does not desire to proceed](#) in becoming an organized congregation of the CRCNA.
 - ii. [FHCRC requests that Classis acquiesce with New Hope's intention](#) of becoming an independent church
 - iii. Suggested Motion: ***that Classis acquiesce in the decision of New Hope to not become an organized church in the CRCNA, but be independent of the CRCNA***
